The awards would be based on anticipated medical related expenses which are not covered by their individual or family health insurance plan. No cash funds are given directly to the grant recipient. When a medical invoice has been sufficiently submitted to the insurance provider, the remaining balance is forwarded to the Organization and it is considered and paid using the pre-approved benefit under this program. If award funds are available, the medical bill is paid on behalf of the participant.

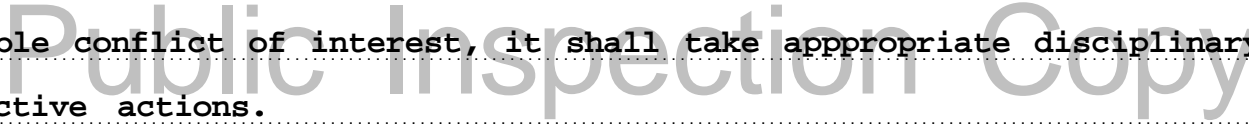
